

August 4, 2009

The Juniata County Commissioners met on the above date with Commissioners Jeff Zimmerman and Teresa O'Neal present. Commissioner Shelley was out of town. Also attending were Juniata Sentinel reporter Maria Yohn, Times Reporter Missy Guiser and Lewistown Sentinel Reporter Micaiah Bilger .

The meeting was called to order at 10:00 a.m. by Commissioner Zimmerman. A moment of silence was observed followed by the Pledge of Allegiance. After adding "The commissioners met with Bob King, King Financial Services at 11:30 p.m. to review the County's retirement investment portfolio, on motion of O'Neal/Zimmerman and unanimously carried, the Minutes of the July 28th meeting were approved.

The following actions were taken:

- On motion of O'Neal/Zimmerman, ratified Fiscal Year 2008/2009 Act 148 invoices submitted by Children and Youth.
- On motion of O'Neal/Zimmerman, ratified CDBG check #370, payable to Deihl's Excavation in the amount of \$1,218.73.
- On motion of O'Neal/Zimmerman, ratified Housing Rehab checks #198 and 199, payable to Michael Felmler in the amounts of \$4,800.00 and \$1,711.00 respectively.
- On motion of O'Neal/Zimmerman, approved Application for County Aid submitted by Delaware Township for paving T-556, T-501 and T-503 in the amount of \$4,628.99.
- Tabled a recommendation from the County Records Improvement Fund committee to purchase a printer for Commissioner O'Neal's office.
- On motion of Zimmerman/O'Neal approved a recommendation from the County Records Improvement Fund committee to purchase a desk base radio at a cost of \$675.00 for the Sheriff's office.
- On motion of O'Neal/Zimmerman approved HazMat check #1040, payable to Office Depot in the amount of \$98.09.
- On motion of O'Neal/Zimmerman approved a Greenway, Open Space and Rural Recreation Plan check #122, payable to YSM in the amount of \$1,311.33.
- On motion of Zimmerman/O'Neal, approved the submission of the application for the PA Conservation Works Grant.
- On motion of O'Neal/Zimmerman approved a recommendation from the Prison Board for personnel changes at the jail – Donald Peters resignation as full time Sergeant effective July 18, 2009, John Wileman moved from part time to full time corrections officer and Brynn Werich hired as a part time corrections officer effective July 27, 2009. Salaries have been established by union contract.




Retirement Board
