

January 12, 2010

The Juniata County Commissioners met on the above date with Commissioners Jeff Zimmerman, Dale Shelley and Teresa O'Neal present. Also attending were member of the public Clair Bair, Jr., Juniata Sentinel reporter Maria Yohn, Times Reporter Paulette Forry and Lewistown Sentinel Reporter Micaiah Bilger .

The meeting was called to order at 10:00 a.m. by Commissioner Zimmerman. A moment of silence was observed followed by the Pledge of Allegiance. The Minutes of the January 5, 2010 meeting were amended to show a Salary Board meeting was held on January 5th after the Commissioners' Board meeting. The Minutes were then approved on motion of O'Neal/Shelley and unanimously carried.

The commissioners took the following actions:

- On motion of O'Neal/Shelley and unanimously carried, approved a License to Carry Process Subgrant #21117 for the Sheriff's Office in the amount of \$15,000.00.
- On motion of O'Neal/Shelley and unanimously carried, approved a performance evaluation for Susan M. Clark, Caseworker 2 in the Children and Youth Department.
- On motion of O'Neal/Shelley and unanimously carried, approved a performance evaluation for Barbara S. Geedey, Caseworker 2 in the Children and Youth Department.
- On motion of O'Neal/Shelley and unanimously carried, approved an engagement letter with Colledge and Snyder at a cost of \$70/hour. Commissioner O'Neal suggested the costs be monitored since implementation of the Unifund system was to cut the cost.
- On motion of O'Neal/Shelley and unanimously carried, approved a Legal Services Agreement with Donis H. Zagurskie to provide services to Domestic Relations from January 1, 2010 through September 30, 2010 at a rate of \$75/hour.
- On motion of O'Neal/Shelley and unanimously carried, approved HazMat check #1051, payable to Sheetz Advantage in the amount of \$57.62.
- On motion of O'Neal/Shelley and unanimously carried, approved tax exonerations for Susquehanna, Fermanagh, Fayette and Spruce Hill Townships.
- On motion of O'Neal/Shelley and unanimously carried, approved a recommendation from D.A. Snook to appoint John K. Mort to the Assistant D.A. position effective January 11, 2010.
- Acknowledged receipt of the December Monthly Statistical Report from Helen Henry, Children & Youth Director.
- On motion of O'Neal/Shelley and unanimously carried, approved the First Quarter Report of Expenditures for 2009/10 submitted by Helen Henry Children and Youth Director. The report covers June 1, 2009 through September 30, 2009.
