The Juniata County Commissioners met on the above date with Commissioners Jeff Zimmerman, Robert Reynolds and Teresa O'Neal present. Also attending were Juniata Sentinel reporter Maria Yohn and Sentinel reporter Julianne Cahill.

The meeting was called to order at 10:00 a.m. by Commissioner Zimmerman. A moment of silence was observed followed by the Pledge of Allegiance. On a motion by Reynolds and a second by O'Neal, the Minutes of the May 14, 2013 meeting were unanimously approved as submitted.

There being no public comment, the Commissioners took the following actions:

- It was moved by O'Neal and seconded by Reynolds to approve the tax exonerations for Fermanagh Township as per the material provided. The motion was unanimously carried.
- It was moved by Reynolds and seconded by O'Neal to approve a request for Liquid Fuel Funds for Mifflintown Borough in the amount of \$2,193.75. The motion was unanimously carried.
- The Commissioners reviewed the April 2013 Field Assessment Totals Report as submitted by Jeff Haines, Chief Assessor.
- It was moved by O'Neal and seconded by Reynolds to ratify the following CDBG-IDIS checks as submitted by Dave Bardell, Planning Director. The motion was unanimously carried.

- It was moved by O'Neal and seconded by Reynolds to approve checks #37570 - #37633 in the amount of \$88,856.99. The motion was unanimously carried.
